 - Requested any objections. None offered and will proceed with planned migration
- NSWRYA WebSite refresh Peter Zecchin
 - New Website will have same content and general refresh is coming
 - One feature will enable clubs to have their own Page.
- NSWRYA Affiliate club venue risk assessments require update Peter Zecchin
 - All clubs will be asked to conduct and record risk assessment and return to "file" with NSWRYA by December 2022.
 - NSWRYA will provide Template and examples to support clubs conducting and recording their own.
 - o lan Stevens volunteered his experience to help develop template for clubs to complete.

 - Fee relief is not the main point, open item for further thought in the future.
